The Agency for Healthcare Research and Quality (AHRQ) is starting a plan to modernize the content of the MEPS. AHRQ intends to use technological advances that can improve the means of collecting data.to better reflect changes in health care policy and healthcare delivery. Moreover, impacts from the COVID-19 pandemic require different strategies for collecting data given a

reluctance among some household members to participate in face-to-face information collection.

AHRQ will include updates to all of MEPS' survey components (Household, Medical Provider, and the Insurance. This session will introduce the broad areas the Agency is considering as part of the MEPS redesign and an opportunity for MEPS users to provide feedback on this effort.
