These abstracts will also be used to connect you with other early-career researchers with similar interests to allow you to consult with one another (although they will not be shared with these other attendees without your permission). Federal Government Registration Rate

Trainee Discount Requirements

Individuals enrolled in a full-time Ph.D. program, Post-doctoral fellowship, or Master's Degree program are eligible for the trainee discount of \$120 off the registration fee. Trainees are required to supply a letter from their training Program Director at the time of registration ${\sf Program}$ to receive the discount. The letter must state active dates of student or fellowship terms. Registration forms submitted without a letter of support will not be processed

Substitutions


