### **CALL FOR PAPERS**

The Gerontologist: Implementation Science in Gerontology

For this special issue, we welcome papers that reflect how researchers and practitioners are broadly applying implementation science frameworks and methods (vs. strictly an efficacy or effectiveness trial) across a variety of disciplinary backgrounds. Works by persons belonging to underrepresented groups or studying diverse and underrepresented older adults are encouraged. We will accept all manuscript types including Research Articles (qualitative and quantitative), Intervention Research, and Forum Articles—and (published online only) Review Articles and Measurement Articles, reflecting the range of implementation science scholarship, including studies of quality improvement, rigorous program evaluations, findings from hybrid-effectiveness trials, exemplary implementation trial protocols, and examples of innovative education or training models focused on implementation science. Successful papers will use or build upon frameworks for implementation science practice and research and, as with all papers accepted in *The Gerontologist*, demonstrate theoretical, conceptual, and methodological rigor regardless of the manuscript type.

To avoid duplicative topics and to enable us to develop a comprehensive issue, a 250-word abstract describing the paper's intent should be submitted. Please be sure to include all author names and contact information for the corresponding author. Our team of editors will identify abstracts of interest and selected authors will be invited to submit full manuscripts. Full manuscripts will be evaluated using *The Gerontologist*'s usual peer-review process.

Before submission, authors should carefully read the Author Guidelines for *The Gerontologist* located at <u>oxford.ly/TG\_ITAs</u>. Abstracts should be submitted electronically at <u>mc.manuscriptcentral.com/tg</u> according to the following timetable:

<u>The National Institute of Nursing Research (NINR)</u> *Strategic Plan for 2022–2026* identifies three goals for nursing science:

- Dismantling structures that perpetuate racism and impede health equity.
- Addressing social determinants of health using multilevel methods.
- Advancing precision health and health care.

In this call for papers, we seek cutting-edge nursing science research that addresses these challenges in the setting of aging and lifespan health. Manuscripts should be empirically based but may make projections for a possible future vision for the field.

Dear AcademyHealth Disparities Interest Group members,

Some of us were looking forward to a much-needed spring break- or for others, at least a pause- we spent the week in mourning, anger, and perhaps most of all, exhaustion. Amidst our grief, it truly helps to know that we are not alone.

I thank all of you for your continued support as we, in the leadership, made the decision to focus this year's activities on the role of structural racism in the creation and perpetuation of health inequities. I know that health 'disparities' spans a multitude of sources of injustice.
